Application Form

One application form to be completed.

Photos

One recent passport size photo (JPEG).

Passport

Scan copy of your passport's information page valid 6 months after the date of arrival and must have two blank pages.

Yellow Fever Certificate

A copy of Yellow Certificate.

Business Letter

A letter headed company letter (scan copy) addressed to the Embassy and must include the following;

- Full applicant's name;
- The nature of the trip;
- Letter must specifically request the visa type required, with regards to duration and entry requirements.
- Written declaration that the company will take financial responsibility.
- Must also state full passport details of applicant.

Letter of Invitation

An invitation letter from the inviting company in Kenya (scan copy) addressed to the Embassy and must include the following;

- Full applicant's name;
- The nature of the trip;
- Letter must specifically request the visa type required, with regards to duration and entry requirements.
- Written declaration that the company will take immigration responsibility.
- Must also state full passport details of applicant.

Proof of Registration

A copy of Proof of Registration from the company in Kenya.

Visa Information:

You must have an approved electronic Travel Authorization (eTA) to travel to Kenya. Processing time is minimum 4 working day process.

APPLICATION PROCESS

Step 1: Complete the forms and gather all required documents

- Please complete all forms, check to ensure every required item is included and deliver your application to Visas2 for review and submission.

Step 2: Visas2 will process the application

Step 3: Process update and completion
