### **Application Form**

### **Photos**

Two recent passport size photos.

### **Passport**

Please ensure that your passport is valid for at least 6 months from the date application is submitted to Embassy. Please ensure that there is a spare blank page available in your passport.

### **Business Letter**

A letter headed company letter addressed to the Embassy and must include the following;

- Full applicant's name;
- The nature of the trip;
- Letter must specifically request the visa type required, with regards to duration and entry requirements. E.g. 1 Year Multiple Entry;
- Written declaration that the company will take financial responsibility.
- Must also state full passport details of applicant.

### **Letter of Invitation**

Must be on company headed paper and should mention the following information;?

- Applicant's full name;
- The nature of the trip.?
- Duration of stay.?
- Full passport details of the applicant.

### **Supplementary Form**

Please fill a supplementary form.

### **Visa Information:**

Visa takes 7 working days to be issued.

Visa is valid for 3 months.

## **APPLICATION PROCESS**

### **Step 1: Complete the forms and gather all required documents**

- Please complete all forms, check to ensure every required item is included and deliver your application to Visas2 for review and submission.
