GENERAL:

Papua New Guinea welcomes tourists and visitors. Our country is a rapidly developing country and has a great need of skilled people to help in its development. This country has its own Immigration and Labour legislation, the administration of which is the responsibility of the Minister and the Papua New Guinea National Parliament.

All persons entering Papua New Guinea must have a valid permit and a passport to enter. Permits are issued only for the purpose and period stated in the application.

The main condition for issue of permits that are common to all applicants are that they must have accommodation available, be not adversely recorded from a security point of view, be of good character, and be physically and mentally healthy.

An entry permit may be cancelled at any time

ENTRY FOR EMPLOYMENT

Papua New Guinea regulates entry of non-citizens seeking employment in the country.

Under the *Employment of Non-Citizens Act 2007*, which is administered by the Department of Labour and Industrial Relations, a non-citizen cannot engage in any form of employment whether paid or unpaid, unless prior approval is given. Further information may be found online at <http://www.workpermits.gov.pg/>

A non-citizen, who is employed or accepts employment without approval from the Department of Labour and Industrial Relations may have their visa cancelled and be liable for prosecution and deportation. Regular inspections are carried out by inspectors under the Act in Papua New Guinea to ensure these requirements are observed.

WARNING:

Persons who do not observe the following requirements are liable to heavy penalties under Papua New Guinea Immigration Law.

- 1) Entry permit holders must ensure that they always have a valid permit and passport. Holders of expired or cancelled entry permits are prohibited immigrants and may be deported.
- 2) The Migration Act 1978 lays down penalties for persons who deliver or otherwise furnish for official purposes of the government, documents containing information or statements that are false or misleading.

Les personnes qui entrent dans le pays pour des raisons de divertissement, de recherche, de tournage, de journalisme, d'aide humanitaire ou à des fins religieuses sont tenues de déclarer le but de leur visite lors de leur demande d'un permis de séjour. Cette déclaration doit être soutenue par écrit par un sponsor en PNG.

ENTRY FOR EMPLOYMENT / ENTREE POUR UN TRAVAIL

Papua New Guinea regulates entry of immigrants seeking employment in the country. Under the Employment (Training and Regulations) Act 1971, which is administered by the Department of Labour and Employment, an immigrant cannot engage in any form of employment whether paid or unpaid, unless prior approval is given by the Department of Labour and Employment to the prospective employer, upon written request. An immigrant who is employed or accepts employment without approval by the Department of Labour and Employment, becomes a prohibited immigrant and is liable for prosecution and deportation. Regular inspections are carried out by inspectors under the Act in Papua New Guinea to ensure these requirements are observed.

La Papouasie-Nouvelle-Guinée réglemente l'entrée des immigrants cherchant du travail dans le pays. Conformément à la loi Employment (Training and Regulations) Act 1971, administrée par le Département de Labour and Employment (Ministère du travail et de l'emploi), un immigrant n'a pas le droit d'effectuer toute forme de travail, rémunéré ou non rémunéré, avant autorisation préalable à l'employeur du Ministère du travail et de l'emploi, sur demande écrite. Un immigrant qui est employé ou qui accepte un emploi sans l'accord du Ministère du travail et de l'emploi devient un immigrant clandestin, passible de poursuites judiciaires et d'être déporté. Dans le cadre de cette loi, nos inspecteurs effectuent des inspections régulières pour assurer le respect de ces exigences.

WARNING

Persons who do not observe the following requirements are liable to heavy penalties under Papua New Guinea Immigration Law.

1) Entry permit holders must ensure that they always have valid permit and passport. Holders of expired or cancelled entry permits are prohibited immigrants and may be deported.

2) The Migration Act 1976 lays down penalties for persons who deliver or otherwise furnish for official purposes of the government, documents containing information or statements that are false or misleading.

AVERTISSEMENT

Les personnes qui n'observent pas les conditions suivantes seront passibles de lourdes sanctions conformément aux lois sur l'immigration de la Papouasie-Nouvelle-Guinée.

1) Les personnes possédant un permis de séjour doivent s'assurer qu'elles possèdent toujours un permis et un passeport valides. Les personnes qui possèdent des permis expirés ou annulés seront considérées comme des immigrants clandestins et pourront être déportées.

2) La loi sur les mouvements de population de 1976 (Migration Act 1976) établit les sanctions encourues par les personnes qui produisent ou fournissent à des fins gouvernementales officielles des documents contenant des informations ou des déclarations fausses ou trompeuses.
