Application Form

Two fully completed and signed application forms. These forms must:

Be completed in block capitals only

Be signed in blue/black ink only

There is no Embassy representation for this destination in the United Kingdom. All applications are processed overseas with our affiliate partners. Overseas courier fees of £75.00 + VAT per order apply in addition to the fees listed

Passport

The applicant's actual passport. The passport must:

Have two blank facing visa pages

Be valid for six months beyond entry date

Photos

Two passport sized colour photographs. The photographs must:

Have a white background

Be taken within the last six months

Proof of Travel Arrangements

Details of travel arrangements. These must be provided as:

A copy of the hotel confirmation

A copy of the flight confirmation showing onward/return travel

Yellow Fever Certificate

One copy of yellow fever certificate

Visa on Arrival

It may be possible to obtain a visa upon arrival at this destination. There is no guarantee entry will be allowed. Check with the embassy for details and confirm your airline will permit boarding without a visa. To minimise the risk of being refused entry and to avoid excessive

waiting for a visa to be issued on arrival, Visas2 strongly recommends that travellers obtain all visas prior to travel.

Step 1: Complete the forms and gather all required documents

Applications are usually dispatched within 24 hours of release.
