The following documents are required to apply for this specific visa type.

### **Application Form**

One fully completed and signed application form

### **Passport**

The applicant's actual passport. The passport must:

Have at least one blank visa page

Be valid for three months beyond exit date

### **Proof of Residence**

Evidence of UK residency. This must be shown as:

An original permit valid for more than six months from date of visa form submission in a passport that can be supplied

### **Photos**

One passport sized colour photograph. The photograph must:

Have a white background

Be taken within the last six months

Be glued on to the visa application form

### **Proof of Financial Means**

Evidence of available funds. This must be provided as:

A copy of a recent bank statement showing a minimum credit balance of £60.00 per day of stay with a total of not less than £600.00

### **Proof of Travel Arrangements**

Details of travel arrangements. These must be provided as:

Original flight confirmation showing onward/return travel

A copy of the hotel confirmation showing paid in full

### **Proof of Travel Insurance**

Copy of actual travel insurance policy certificate (email not accepted). The certificate must state:

Full name of the applicant

That the policy is valid for the duration of the entire trip

Applicants who are covered by the their company's insurance policy must supply a UK company letter from their employer as proof

### **Photocopy of Application Materials**

A photocopy of the following document(s) submitted to Visas2. These must:

Include the information page(s) of the applicant's passport

Include the applicant's UK residency visa where applicable

Include all valid visas

A £10.00+VAT fee will apply if you prefer to have us make photocopies.

### **Multiple Entry Applicants**

Multiple entry visas are usually only issued if one or more of the following conditions are satisfied:

The applicant has invested more than 50,000 Euros or its equivalent in other currency in the Republic of Bulgaria and there is a document from the Bulgarian Agency for Foreign Investment confirming this;

The applicant is a representative of a person who satisfies one of the above conditions;

The applicant is a member of the family of a Bulgarian citizen;

The applicant has a multiple entry visa valid for more than 12 months for one of the countries the citizens of which enjoy a visa free regime for a short entry in Bulgaria

### **Visa Conditions**

Valid for a stay of up to 90 days in any given period of 180 days

### **Visa Information:**

Visa is valid for One Year

## **APPLICATION PROCESS**

### **Step 1: Complete the forms and gather all required documents**

- Please complete all forms, check to ensure every required item is included and deliver your application to Visas2 for review and submission.
