The following documents are required to apply for this specific visa type.

### **Application Form**

One fully completed and signed application form. This form must:  
Be completed online at [https://www.angola.org.uk/PDF/formularios/visa\\_application.pdf](https://www.angola.org.uk/PDF/formularios/visa_application.pdf)  
Provide answers for all question fields  
Be completed in black ink only  
Be completed in capitals only  
Not be printed back to back  
Applicants are advised that handwritten forms may be accepted at the discretion of the Embassy

### **Passport**

The applicant's actual passport. The passport must:  
Have at least two blank visa pages  
Be valid nine months beyond entry date

### **Proof of Residence**

Evidence of UK residency. This must be shown as:  
Valid UK Visa in actual Passport  
**or**  
An original valid UK residency card plus a colour copy of both sides

### **Photos**

One passport sized colour photograph. The photograph must:  
Have a white background  
Be taken within the last six months  
Adhere to The Passport Office guidelines. Refer to the Passport Photograph Guidelines for clear instructions

### **Proof of Address**

Evidence of UK address. This must be shown as:  
An original recent council tax/water bill/tenancy agreement showing current UK address  
**OR**  
A copy of the applicant's full UK driving license and counterpart showing current UK address

### **Business Letter**

An original letter of introduction from the applicant's UK employer. This letter must:

- Be addressed to the Embassy
- Be on company letterhead paper
- Include the name of the applicant
- Specify the purpose of journey
- Include the name of the organisation(s) to be visited
- Specify the requested number of entries and the length of visa required
- Include an acceptance of financial responsibility for the applicant
- Be signed by the applicant's supervisor or the company's HR department

### **Letter of Invitation**

A letter of invitation from the company the applicant is visiting. A copy is acceptable. This letter must:

- Be in Portuguese
- Be on company letterhead paper
- Include the name of the applicant
- Include the passport number of the applicant
- State the purpose of journey
- Specify the requested number of entries and length of visa required
- Be issued within the last three months
- Be emailed in PDF format to the Embassy by the host from Angola prior to visa submission at [loi@angola.org.uk](mailto:loi@angola.org.uk)

### **Proof of Travel Arrangements**

Details of travel arrangements. These must be provided as:

A copy of the flight confirmation showing date of travel as no earlier than the evening of the fifth day after visa submission. Visas2 recommends booking changeable tickets as processing time is not guaranteed.

### **Photocopy of Application Materials**

A photocopy of the following document(s) submitted to Visas2. These must:

- Include the applicant's recent council tax/water bill/tenancy agreement showing current UK address
- Include all previous Angolan visas in passport supplied
- Include the applicant's UK residency visa where applicable
- Include the information page(s) of the applicant's passport
- A £10.00+VAT fee will apply if you prefer to have us make photocopies.

### **Visa Conditions**

Applicants should check with the SME in Luanda prior to obtaining an invitation to confirm that

they are not blocked. The Embassy only advises an application is blocked on the day of intended collection and will charge full fees even though a visa has not been issued

Applicants **must** travel to Angola within four weeks of visa submission

This visa **must** be used within 96 hours of issuance

Due to technical reasons, once a visa application is submitted to the Embassy, the applicant's passport will be unavailable until the process is completed.

In an emergency the Embassy may return the passport but the process will be summarily cancelled and the applicant will have to re-submit the complete visa application including the payment. To withdraw the passport the applicant must send the request by email to Visas2.

The passport will be returned to Visas2 within 48 hours.

## **APPLICATION PROCESS**

### **Step 1: Complete the forms and gather all required documents**

- Please complete all forms, check to ensure every required item is included and deliver your application to Visas2 for review and submission.

### **Step 2: Visas2 will process the application**

- Once Visas2 have received all required documentation material, complete and signed as necessary the application will be submitted at the first available date according to the consulate's availability.

### **Step 3: Process update and completion**

- Once the visa application is approved/issued, we will advise immediately. Then proceed in collecting the passport/visa from the relevant embassy/consulate and dispatch in line with the agreed return method communicating all tracking information. Applications are usually dispatched within 24 hours of release.

**VISA REQUIREMENTS APPLY TO NATIONALS OF ALL COUNTRIES RESIDING IN THE UK**

Citizens of any nationality who are legally residents in the United Kingdom of Great Britain and Northern Ireland, the Republic of Ireland and the Commonwealth may apply for a visa to enter Angola provided he/she meets the requirements described in this leaflet.

**TO APPLY FOR ANY VISA, THE APPLICANT DOES NOT NEED TO BE PRESENT** (thick as appropriate):

An application form duly completed;

A passport with at least 9 months validity and 2 blank pages;

1 recent colour passport photograph with the name on the back. (Please glue the photo to the application form);

**ORDINARY VISA REQUIREMENTS**

**INVITATION LETTER SENT FROM ANGOLA** (thick as appropriate):

Sent by an Angolan citizen: (must include a copy of Angolan ID Card authenticated by a notary);

Personal Invitation letter;

Itinerary (Air Line Company or Travel Agent). It is not necessary to purchase the ticket.

Company Letter

Itinerary (Air Line Company or Travel Agent). It is NOT necessary to purchase the ticket.

NOTE: A copy of the invitation letter must be attached to the application form when applying for a visa, independently of a fax or e-mail being sent to the Consular Section;

**THE FOLLOWING APPLIES TO ALL APPLICANTS**

**For those travelling on private visit or holidays the following documents are required:**

Bank statement

Letter from employer confirming employment

**EEC citizens are required to present proof of UK residence** (tick the appropriate):

Tenancy agreement  
Council Tax  
Water bill  
Full UK Driving License).

**Non-British citizens are required to prove their legal status** (tick the appropriate):

British Work visa  
Student visa  
Residence visa

Travelling children are required to present full birth certificate (authenticated by the respective body). British children must have their birth certificate authenticated by Foreign Office (Legalisation department)

**PROCESSING TIME: 15 TO 30 DAYS.**

Applicant sometimes may be asked for an interview.  
Additional documents may be required.

#### **IMPORTANT INFORMATION REGARDING PASSPORTS**

Due to technical reasons once a visa application is submitted the applicant's passport will be unavailable until the process is completed.

In an emergency we may return the passport but the process will be summarily cancelled and the applicant would have to re-submit his application including the payment.

**Fee: Single entry £40.00.**

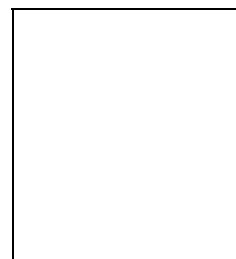
