The following documents are required to apply for this specific visa type.

Application Form

Two fully completed and signed application forms. These forms must:

Be completed in block capitals only

Be signed in blue/black ink only

Photos

Two passport sized colour photographs. The photographs must:

Have a white background

Be taken within the last six months

Proof of Travel Arrangements

Details of travel arrangements. These must be provided as:

A copy of the hotel confirmation

A copy of the flight confirmation showing onward/return travel

Passport

The applicant's actual passport. The passport must:

Have two blank facing visa pages

Be valid for six months beyond entry date

Visa on Arrival

ne copy of yellow fever certificateIt may be possible to obtain a visa upon arrival at this destination. There is no guarantee entry will be allowed. Check with the embassy for details and confirm your airline will permit boarding without a visa. To minimise the risk of being refused entry and to avoid excessive waiting for a visa to be issued on arrival, Visas2strongly recommends that travellers obtain all visas prior to travel.

APPLICATION PROCESS

Step 1: Complete the forms and gather all required documents

- Please complete all forms, check to ensure every required item is included and deliver your application to Visas2 for review and submission.

Step 2: Visas2 will process the application

Step 3: Process update and completion

Applications are usually dispatched within 24 hours of release.
