

# Visa Information Pack

## **Thank you for your order**

The following documents are required to apply for this specific visa type.

### **Application Form**

One fully completed and signed application form. This form must:  
Be printed on a colour printer  
Be supplied back to back on one piece of paper.

### **Passport**

The applicant's actual passport. The passport must:  
Have at least four blank visa pages  
Be valid for six months beyond exit date

### **Proof of Residence**

Evidence of UK residency. This must be shown as:  
Valid UK Visa in actual Passport  
**or**  
An original valid UK residency card plus a colour copy of both sides

### **Photos**

One passport sized colour photograph. The photograph must:  
Have a white background  
Be taken within the last six months  
Be glued on to the visa application form

### **Business Letter**

An original letter of introduction from the applicant's UK employer. This letter must:  
Be addressed to the Embassy  
Be on company letterhead paper  
Include the name of the applicant  
Specify the purpose of journey  
Include the name of the organisation(s) to be visited  
Specify the requested number of entries and the length of visa required  
Include an acceptance of financial responsibility for the applicant  
Be signed by the applicant's supervisor or the company's HR department

### **Letter of Invitation**

An original letter of invitation from the company the applicant is visiting. This letter must:

Be on company letterhead paper

Include the name of the applicant

Specify the purpose of journey

Specify the requested number of entries and the length of visa required

Include an acceptance of financial responsibility for the applicant

Be signed by the authorised person named in the letter

Be written within one month of visa application submission

### **Proof of Financial Means**

Evidence of available funds. This should be provided as:

A copy of a recent bank statement showing a minimum credit balance of £35.00 per day of stay

### **Proof of Travel Arrangements**

Details of travel arrangements. These must be provided as:

A copy of the hotel confirmation

A copy of the flight confirmation which must be faxed to the Embassy prior to lodging on 020 7590 7822

### **Multiple Entry Applicants**

Applicants requiring a multiple entry visa must:

Ensure that the flight booking shows multiple trips

### **Visa Information:**

## **APPLICATION PROCESS**

### **Step 1: Complete the forms and gather all required documents**

- Please complete all forms, check to ensure every required item is included and deliver your application to Visas2 for review and submission.
