The following documents are required to apply for this specific visa type.

### **Application Form**

One fully completed and signed application form

### **Passport**

The applicant's actual passport. The passport must:

Have at least one blank visa page

Be valid for two months beyond exit date

### **Proof of Residence**

Evidence of UK residency. This must be shown as:

Valid UK Visa in actual Passport

**or**

An original valid UK residency card plus a colour copy of both sides

### **Photos**

One passport sized colour photograph. The photograph must:

Have a white background

Be taken within the last six months

### **Proof of Travel Insurance**

Copy of actual travel insurance policy certificate (email not accepted). The certificate must state:

Full name of the applicant

That the policy is valid for the duration of the entire trip

Applicants who are covered by their company's insurance policy must supply a UK company letter from their employer as proof

### **Proof of Immigration Status of Host**

Proof of immigration status of the host. This must:

Include a copy of the "permiso de residencia en el exterior" of the host

Include a copy of the information page(s) of the host's passport including their residency stamp [if applicable]

### **Consular Fees**

The consular fee quoted comprises of the processing fee and the consular fee as levied by the Embassy

### **Visa Information:**

visa is valid for one month

## **APPLICATION PROCESS**

### **Step 1: Complete the forms and gather all required documents**

- Please complete all forms, check to ensure every required item is included and deliver your application to Visas2 for review and submission.

### **Step 2: Visas2 will process the application**

- Once Visas2 have received all required documentation material, complete and signed as necessary the application will be submitted at the first available date according to the consulate's availability.

### **Step 3: Process update and completion**

- Once the visa application is approved/issued, we will advise immediately. Applications are usually dispatched within 24 hours of release.

- Application fee of £15.00 (cash, postal orders or bank-counter cheques payable to *The Cuban Consulate*) are acceptable. **Personal cheques are not accepted.**
- All mailing services must be covered by the applicant. Send a SAE for your receipt and notification of authorization.  
Please note that family visa processing takes a minimum of 4 weeks, if your relative doesn't have PRE

**WHEN THE VISA IS AUTHORIZED YOU MUST SUBMITT:**

- Passport (**valid for 6 months after departure from Cuba**)
- Visa fee of £36.00
- A SAE for the return of your passport. The Consulate cannot be held responsible for documents lost in the mail. We recommend the use of Recorded Mail or Special Delivery. Family visas are issued for ONE entry in Cuba for a maximum stay of 30 days. Longer stays will require extensions made in Cuba. ....
