The following documents are required to apply for this specific visa type.

### **Application Form**

One fully completed and signed application form

### **Passport**

The applicant's actual passport. The passport must:

Have at least one blank visa page

Be valid for six months beyond exit date

### **Proof of Residence**

Evidence of UK residency. This must be shown as:

An original permit valid for more than six months from date of visa form submission in a passport that can be supplied

### **Proof of Travel Arrangements**

Details of travel arrangements. These must be provided as:

A copy of the flight confirmation

A copy of the hotel confirmation

### **Proof of Travel Insurance**

Copy of actual travel insurance policy certificate (email not accepted). The certificate must state:

Full name of the applicant

That the policy is valid for the duration of the entire trip

Applicants who are covered by their company's insurance policy must supply a UK company letter from their employer as proof

### **Visa Information:**

Visa is valid for Six Month

## APPLICATION PROCESS

### **Step 1: Complete the forms and gather all required documents**

- Please complete all forms, check to ensure every required item is included and deliver your application to Visas2 for review and submission.

### **Step 2: Visas2 will process the application**

- Once Visas2 have received all required documentation material, complete and signed as necessary the application will be submitted at the first available date according to the consulate's availability.

### **Step 3: Process update and completion**

- Once the visa application is approved/issued, we will advise immediately. Then proceed in collecting the passport/visa from the relevant embassy/consulate and dispatch in line with the agreed return method communicating all tracking information. Applications are usually dispatched within 24 hours of release.

### MAIN INFORMATION OF PAYMENT METHODS

**TOURIST CARD (TOURIST VISA) FEE: £15.00. YOU MAY APPLY BY POST, COURIER OR IN PERSON.**

**All consular services carried out by post or courier, require an additional non-in person fee of £19, paid only once for one or more persons.**

**IN PERSON:** cash, postal orders and banker's drafts payable to The Cuban Consulate are accepted. Personal cheques are not accepted.

**BY POST:** postal orders and banker's drafts payable to The Cuban Consulate are accepted. Cash and personal cheques are not accepted.

Please: enclose a pre-paid self addressed envelop for the return of your documents as the non in person fee does not cover the postage costs of their return. We recommend the use of recorded mail or special delivery.

A Tourist Card is valid only for one entry within 180 days after the date of issue. It is valid for a 30-day stay in Cuba, extendable in Cuba for a further 30 days maximum.

**Once a tourist card has been issued it cannot be changed or refunded.**

**WHEN APPLYING YOU MUST SUBMIT:**

- Completed and signed application form.
- Full payment.
- Photocopy of the main page of your passport (Passport must be valid for 2 months after departure from Cuba). If you are not from EU, Canada, Australia, Japan, South Africa or USA passport holder you have to submit a photocopy of your British visa valid for 6 months after departure from Cuba.
- . Confirmation of travel arrangements (return tickets) and accommodation Booking.
