The following documents are required to apply for this specific visa type.

Application Form

The applicant must complete one visa application form.

Passport

A scan copy of passport valid for at least six (06) months

Photos

The applicant passport size photo as JPEG scan copy.

Yellow Fever Certificate

A scan copy of valid yellow fever vaccination certificate.

Proof of Travel Arrangements

This must be presented as:

Scan copy of proof of travel arrangements, including return or onward flight bookings

Scan copy of proof of accommodation bookings or an invitation letter from a host in Cameroon

Proof of Financial Means

Scan copy of evidence of sufficient financial means, such as recent bank statements

Proof of Address

A scan copy of utility bill showing applicant's name and address.

Visa Information:

A tourist multiple-entry visa valid for three months allows a UK citizen to enter Cameroon multiple times within a 90-day period for tourism and leisure purposes. This visa is ideal for travellers planning short visits or multiple trips to Cameroon within a limited timeframe.

The applicant must hold a valid UK passport with at least six months of validity beyond the date of first entry into Cameroon and at least one blank visa page.

APPLICATION PROCESS

Step 1: Complete the forms and gather all required documents

- Please complete all forms, check to ensure every required item is included and deliver your application to Visas2 for review and submission.

Step 2: Visas2 will process the application

- Once Visas2 have received all required documentation material, complete and signed as necessary the application will be submitted at the first available date according to the consulate's availability.

Step 3: Process update and completion

- Once the visa application is approved/issued, we will advise immediately. Applications are usually dispatched within 24 hours of release.

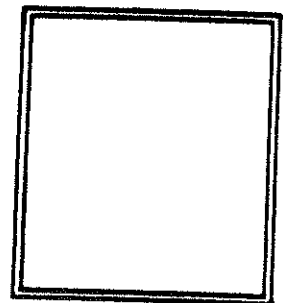
