Business Letter

Should be on letter headed paper from your company, it should be addressed to the Embassy and must include the following;

1. The nature of the trip.
2. Letter must specifically request the visa type required, with regards to duration and entry requirements. E.g. 1 Year Multiple Entry
3. Written declaration that the company will take financial responsibility.
4. Must also state full passport details of applicant.

Invitation Letter

Original headed company invite letter from Central Africa Republic with passport details and full name of the applicant as in the passport. Invitation letter must have a company stamp.

APPLICATION PROCESS

Step 1: Complete the forms and gather all required documents
